4.1 Collaborate with other research libraries to promote and preserve commonly held research assets and selected resources unique to the university or to the region in a manner that assures continuity of content and global access.

4.1.1 Participate in the VIVA IMLS grant application process for a VIVA digital repository

Collaborated with universities statewide to apply for IMLS (Institute for Museums and Library Services) grant program. The request includes \$64,000 for Virginia Tech. The program awards are in September 2007. The proposal supports collections across the Commonwealth which fit under the concept of "America's Struggles for Freedom"

5.1 Continue implementation of the Innovative Interfaces System.

5.1.1 Bring metasearching and web bridge applications to an operational state for our users

WebBridge went live in October 2006. Since then the team:

- gathered usage statistics and held focus groups in order to provide subject specialists with feedback about the resources selected.
- Held an open forum for library staff on May 30, 2007
- Investigated book review products and conducted trials of products
- Worked with Marketing Team to publicize WB

ArticleExplorer is linked from the library web site. All but a few VT resources are profiled. ResearchPro is due out in late 2007. This upgraded version of our federated search product will provide enhancements to our current user interface.

5.2 Respond to information-seeking behaviors of the user community when organizing and providing library resources

5.2.1 Begin conversion of the library website to conform to Virginia Tech's new 'corporate look' website

The Libraries Web Team, and the Research and Instructional Services Department's Web Working Group conducted a number of studies and usability tests of the Library website as a preliminary assessment of what activities users are conducting on the Library website and how easily they can find the information they are looking for. This information will be used in the website redesign process. The recent hiring of a University Libraries webmaster this summer has provided the library with the needed expertise and dedicated time to begin work towards the conversion of the library website to conform to Virginia Tech's new 'corporate look' website

5.2.2. Determine participants and arrange for periodic meetings to develop a group of library staff from each director's group who are knowledgeable about using Innovative Interfaces canned and query statistics operations (All units)

The Technical Services unit has been the most active unit in pursuing this goal

- Annette Bailey leads monthly meetings of directors and other staff that focus on different aspects of Millennium statistics and reports.
- Four TS staff participate in monthly meetings, provide training for other library staff, evaluate queries, and serve as resources.
- Seven TS staff attended sessions at the Innovative Users Group meeting on Millennium statistics and Web Management Reports.
- Eight TS staff members use Millennium statistics module routinely for database maintenance support, statistical reporting, and special projects.
